h) **Defect Liabilities Period** : If any damage shall happened to the work for any cause whatsoever or any imperfection become apparent in it at any time whether during its execution of within a period of 3 years from the actual date of completion certificate issued by the Engineer in Charge. The contractor shall make the same goods at his own expense or in default, the Engineer in Charge may cause the same to be made good by other workmen and deduct the expense from any sums, whether under the contact or otherwise that may be then, or at any time thereafter become due to the contractor from the Government or from his security deposit.


